Article 1: The contents of investment projects:

- 1. Name of the investment project: FROMM GERMAN OIL & LUBRICANT TECHNOLOGY FACTORY.
- 2. Objective and scale of the project:
 - Manufacturing lubricants and petrochemical products (except gasoline) to the scale of 100,000 tons/ year.
 - To provide chemical testing services, engineering services related to Lubricants products and petrochemical products (except gasoline).
